#### **ANNEXURE - I**

### **General Terms and Conditions**

- **1.** Jagat Guru Nanak Dev Punjab State Open University, Patiala invites bids for "Hiring of vehicles" through Open Tender.
- **2.** Henceforth, the University will be referred as First Party and the Bidder will be referred as second party.
- **3.** The Vehicle should not be older than five years of manufacture.
- **4.** Interested bidders can download the tender documents online from website <a href="https://www.psou.ac.in">https://www.psou.ac.in</a>
- 5. The bidders will have to deposit Earnest Money Deposit (EMD) of Rs 10,000/- in the form of Demand Draft along with the tender.
- **6.** Corrigendum/Addendum/Corrections, if any, will be published on the website <a href="https://www.psou.ac.in">https://www.psou.ac.in</a>
- 7. The successful bidder shall be required to sign the contract as per this tender document within 15 days of deposit of the Performance Security.
- 8. The successful bidder shall have to provide vehicle within a period of 02 days from the date of the signing of the contract. If the successful bidder fails to provide vehicle within a period of 03 days from the date of signing of the contract, the Bid Security deposited by the said bidder shall be forfeited by Competent Authority and the next ranked bidder shall be invited to sign the contract by way of issuing a supply/acceptance order.
- 9. The vehicles to be provided by the second party shall be in excellent working condition and the vehicle should not be later than the previous year of manufacture at the time of hiring and should be of BS-VI. The vehicle should be kept neat and clean and in perfect running condition with clean interiors and the vehicle should have seat covers, audio system and foot mats etc.
- 10. The vehicle provided by the second party must have valid permit for running on hire. It should be insured as per existing laws and rules at all terms. The insurance charges, license charges for running on hire, road tax etc. will not be borne or reimbursed by the first party. However, toll taxes, if any, will be

reimbursed on producing vouchers by the second party at the end of the each month.

- 11. The vehicle shall be for the exclusive use of Jagat Guru Nanak Dev Punjab State Open University, Patiala. During the period of the contract with the University, the vehicle shall not be used by the second party for any other purpose, such as plying for other parties or for personal use etc.
- 12. During the period of contract, the vehicle shall be at the disposal of the first party for whole period. The vehicle can be called at any time. The vehicle would remain at the disposal of the department for all seven days in a week during the entire contract period.
- 13. In the event of emergency break down of a vehicle or absence of driver, the second party shall make alternative arrangement by providing a substitute vehicle of current year model and driver.
- **14.** The driver should have valid driving license with the minimum of three years of driving experience for the class of vehicle offered for hire.
- 15. The driver should be decent and well behaved. The driver should not have criminal antecedents and it shall be responsibility of the second party to verify his background before deployment. The conduct of the driver will be sole responsibility of the second party and in this regard. The first party shall not be responsible in any manner, whatsoever. Work and conduct of the driver should be satisfactory.
- **16.** The driver on duty should be provided with mobile phone by the second party, at his cost, for easy communication.
- 17. The second party and driver shall be bound to carry out the instruction of the first party as well as of the controlling officer of the vehicle
- 18. In case of any accident, all the claims/damages arising out of same, shall be borne by the second party. The second party shall be responsible for any loss/damage to property or life due to negligence of driver or poor maintenance of vehicle or due to an accident. The first party shall not be responsible for any such loss/damage.
- 19. The second party shall be responsible for the suitability, medical fitness and police verifications of the character and antecedents of the manpower engaged by it for deployment and for satisfactory implementation of the service.

- **20.** The second party shall fulfill the various conditions stipulated by law, Government orders/notifications etc. in respect of hiring and safety of vehicle.
- **21.** The drivers provided by the second party shall not do any private work other than the assigned duties.
- **22.** The second party or his representative shall ensure that all his personnel/driver will be have courteously and decently with the officers/official of the University and also ensure good manners.
- **23.** That the vehicle provided by the second party should carry a designation plate as decided by the first party and for which no separate payment shall be made. The designated plate should be covered when concerned officer is not occupying the vehicle.
- **24.** A log book shall be maintained by the driver which will be duly certified by the controlling officer.
- **25.** The second party shall submit the monthly bill in triplicate enclosing the summary sheet within seven days before the end of the month which should be duly verified by the controlling officer. Payment will be released after making necessary verification.
- **26.** First party may, without prejudice to any other remedy for breach of contract, by giving 15 days written notice of default sent to the second party, terminate the contract in whole or in part:-
- i) If the second party fails to perform the maintenance service within the time period (s)specified in the contract, or any extension thereof granted by first party : or
- ii) If the second party fails to perform it's any other obligation(s) under the contract.
- iii) Any other valid reason conveyed by 1st party.
- 27. First party may at any time terminate the contract by giving written notice to the second party, without compensation to the second party, if the second party becomes bankrupt or otherwise, insolvent, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to first party. In case the second party wants to withdraw the contract, it will serve at least 3 months prior notice to first party.
- **28.** In case of any dispute, the matter shall be referred to the Vice Chancellor of the University.
- **29.** Registrar, Jagat Guru Nanak Dev Punjab State Open University Patiala, reserves the right to amend the bid documents or extend the deadline for submission of bids.

- **30.** The distance will be calculated from University to University.
- **31.** The vehicle shall include driver, fuel, Insurance, Repair and Maintenance etc.
- 32. Driver will wear proper uniform and will be physically & mentally fit.
