- 2. The bidder shall strictly abide time schedule given by University for delivery of the material/items as per work order.
- 3. Validity of the bid is 90 days from the date of opening quotation.
- 4. Selected bidders are strictly prohibited for subletting the assigned work/work order.
- 5. Incomplete and conditional Quotation will not be accepted.
- 6. The Registrar, Jagat Guru Nanak Dev Punjab State Open University, Patiala reserves the right to cancel the bid without assigning any reason.
- 7. Copy of PAN No. (PAN Card) of firm must be attached.
- 8. Payment shall be made in Indian rupees on Final acceptance & after verification by the specified consignees and their issue of clearance & acceptance certificates to the satisfaction of the authority.
- 9. If the material is not delivered on or before the due date the competent authority will have the right to deduct 2% of the total bill for every weeks default, no extension time will be permitted. The decision of the University shall be binding on the bidder in this regard.
- 10. All disputes, differences, claims and demands arising under or pursuant to or touching the contract shall be referred to the sole arbitrator i.e. the Registrar JGND PSOU, Patiala. The award of the sole arbitrator shall be final and binding on both the parties under the provisions of the Arbitration and Conciliation Act, 1996 or by statutory modification re-enactment thereof for the time being in force. Such arbitration shall be held at Patiala.
- 11. Firms must quote rates with installation of items at three different locations of JGND PSOU Patiala.
- 12. No extra service/other charges will be paid.
